

NSFGA 2012 RESOLUTION #2: ARTICLES OF ASSOCIATION – NOTICE OF MOTION

WHEREAS the Articles of Association (By-laws) of the Nova Scotia Fruit Growers' Association may be slightly outdated; and

WHEREAS there may need to be modification to the Articles of Association (By-laws); and

WHEREAS Section 12 of the Articles of Association specifies the method required for changing the Articles;

THEREFORE BE IT RESOLVED THAT this resolution is serving as NOTICE OF MOTION that a motion to change the Articles of Association of the Nova Scotia Fruit Growers' Association may be put forward at the 2013 Annual General Meeting.

NSFGA 2012 RESOLUTION # 3: INDUSTRY FUNDING FOR TREE FRUIT RESEARCH (amended)

WHEREAS the Federal Government has raised the industry cash contribution required to leverage project funding from 10% to a minimum 25%,

AND WHEREAS having a multi-facetted, long-term, tree fruit research program in place is critical in maintaining and advancing the industry's competitiveness,

AND WHEREAS the NSFGA does not receive enough revenue from membership fees or from the return on its investments to provide the required 25% cash contribution to support such a research program,

AND WHEREAS the Nova Scotia Tree Fruit Research Foundation (NSTFRF) is moving to change its corporate status from not-for-profit to charitable for the purpose of attracting charitable donations from other charitable organizations so that donations may be invested and the returns used to support tree fruit research,

THEREFORE BE IT RESOLVED THAT the NSFGA supports the NSTFRF's efforts to change its corporate status to charitable.

NSFGA 2012 RESOLUTIONS #4: AGRISTABILITY

WHEREAS AgriStability is an Agricutlure and Agri-Food Canada (AAFC) margin-based business risk management program which allows producers to protect their farm operations against large declines in farm income,

AND WHEREAS AgriStability assistance is triggered when a producer's production margin in a program year drops below 85% of his/her reference margin (olympic average of the previous 5 years) or more than 15% below his/her historical reference margin,

AND WHEREAS starting in the 2013 program year AgriStability will only provide assistance if a producer's margin falls below 70% of his/her reference margin or 30% below his/her historical reference margin,

AND WHEREAS this change will be very harmful to producers, particularly those who have diversified farm operations,

THEREFORE BE IT RESOLVED THAT the NSFGA request that AAFC maintain the 85% trigger figure,

FURTHER BE IT RESOLVED that the NSFGA request that CHC lobby AAFC for continuation of the 85% trigger figure,

AND FURTHER BE IT RESOLVED that the NSFGA request that the NS Federation of Agriculture request that the Canadian Federation of Agriculture lobby AAFC for continuation of the 85% trigger figure.

Resolutions and Nominations from the 2011–2012 NSFGA Annual General Meeting, Nov. 27, 2012

NSFGA 2012 RESOLUTION #5:

UTILITY DEDUCTIONS FROM SEASONAL AGRICULTURAL WORKER PROGRAM (SAWP)

WHEREAS Nova Scotia's minimum wage rate is at or above the National level

AND WHEREAS Nova Scotia's utility costs are among the highest in Canada

AND WEHREAS in the Apple Industry wages are our highest cost of production expense

AND WHEREAS Alberta, Saskatchewan, Ontario, PEI, New Brunswick and Manitoba may deduct \$2.16 per day of work from their SAWP worker's pay to offset utility costs

THEREFORE BE IT RESOLVED THAT we ask the Nova Scotia Federation of Agriculture to lobby the proper Government Departments to have this deduction allowable to Nova Scotia employers in the SAWP.

NSFGA 2012 RESOLUTION #6:

FOREIGN SEASONAL AGRICULTURAL WORKER HEALTH INSURANCE

WHEREAS, each year, Nova Scotia horticultural producers bring in foreign seasonal agricultural workers which totaled 843 in 2012, mainly from the Caribbean – Jamaica and Barbados and Mexico.

WHEREAS, they contribute significantly to the sustainability of the farms they work on and contribute positively to their local communities. They also contribute to the tax base of this province by purchasing many local goods and services.

WHEREAS, the work they do has allowed their employers to expand and create business opportunities, which in turn has led to more purchase of local goods and services.

WHEREAS, the province of Ontario has in the vicinity of 15,636 foreign seasonal agricultural workers and each of those workers is covered under OHIP – Ontario Health Insurance Plan.

THEREFORE BE IT RESOLVED that the NSFGA request the Nova Scotia Government and the Nova Scotia Department of Health extend Nova Scotia Health coverage to our foreign seasonal agricultural workers.

Container Sizes

OTTAWA, November 22, 2012: The Canadian Food Inspection Agency (CFIA) is proposing to eliminate current restrictions that limit the size of containers for certain foods. These restrictions provide no food safety benefit. To validate this feedback, the CFIA plans to launch a formal consultation in 2013 as part of the standard regulatory amendment process. Proposed changes, which will include a flexible implementation time frame of up to five years, as well as a detailed assessment of potential impacts, will be posted on the Canada Gazette website, www.gazette.gc.ca.

Until the regulatory process concludes, the current regulations will remain in force. CFIA compliance and enforcement activities will continue. In addition, Ministerial Exemptions and Test Market Authorizations related to container sizes will continue to be administered.

The Nova Scotia Federation of Agriculture (NSFA) and the Ecology Action Centre are pleased to receive word that the Environmental Goals and Sustainable Prosperity Act (EGSPA) now include food goals.

As the Nova Scotia Legislature rose last week and the Green Economy Act, Bill 136 was proclaimed. the inclusion of two food goals in EGSPA is official.

The following are the two goals:

- local food consumption is supported and encouraged, with the goal of 20 per cent of the money spent on food by Nova Scotians being spent on locally produced food by 2020;
- local food production is supported and encouraged, with the goal of increasing the number of local farms by five per cent by 2020.
